# 1743 Minutes

The minutes of the meeting of the Parish Council (PC) meeting held on 13 June 2012 were approved by the meeting and signed by the chairman, subject to the following amendment:

# 1744 Code of Conduct

(i) **RESOLVED** (proposed Cllr Roberts, 2<sup>nd</sup> Cllr Knight) to adopt the new Members Code of Conduct provided by the National Association of Local Councils, without amendment

(ii) **RESOLVED** (proposed Cllr Knight, 2<sup>nd</sup> Cllr Green) to adopt amendments to Standing Orders resulting from the new code of conduct

(iii) Councillors wishing to attend training on the new code on 7 August will advise the clerk.

# 1745 Finance

**RESOLVED** (proposed Cllr Knight, 2<sup>nd</sup> Cllr Roberts) to pay:

SALC – fees for training in new code of conduct –Maximum £120 depending on take-up. Staff salaries June 2012.

(ii) The financial statement for the current year to date was noted.

# 1746 Planning

(i) The council considered the following application and recommended approval

**2012/1410** The Mill, Foxcote, Shoscombe, Bath BA2 8NG. To provide disabled access to the house via a ramp and deck area. This amends previous planning permission granted for a walkway, deck area and stairs, wrapping around a corner of the house. The house was created, but the raised outside area was never built. Proposal is to build the raised area of deck, but with amendments to the original permission.

(ii) Noted that Mendip had approved the following applications.

2012/ 1180 Byre Croft, The Green, Faulkland BA3 5UZ. Discharge of condition 1 (materials) of planning consent 102211/004.

2012/0395 Faulkland Farm, Grove Lane, Faulkland, BA3 5UU. Excavations for dirty water storage. Change of use from pasture land.

(iii) Mendip Strategic Housing Land Availability Assessment (SHLA)

Councillors discussed information received from Mendip on the SHLAA.

The chairman invited contributions from members of the public.

**RESOLVED** To circulate to every household in the parish available information on the SHLAA.

**RESOLVED** To finalise details of the mailing at the August PC meeting.

# 1747 Allotments

(i) **RESOLVED** (proposed Cllr Green) to ask the allotment committee to tidy the site

(ii) Rents totalling £740 had been received.

Councillors welcomed an anonymous donation of £740.towards provision of a water supply to the allotments.

**RESOLVED** (proposed Cllr Knight, 2<sup>nd</sup> Cllr Green) to proceed with provision of the water supply to the site. Bristol water connection cost £970.

(ii) Details of the procedure for reporting potholes to be put on the notice board and website. Potholes at the entrance to Tuckers Grave car park and at Keeper's Cottage to be reported.

(i) Noted that the height of some play equipment is above the safety height for grass. Estimates to be obtained to install edging and bark surface for presentation to the August PC.meeting.

(ii) If the Frome football club which had asked about using the pitch is still interested, an invitation to be issued to come to the August PC meeting.
