1767 Minutes

RESOLVED that the minutes of the PC meeting of 8 August 2012 be accepted as a true record with the following two amendments.

1769 Planning

(i) **RESOLVED** to recommend approval of the following three applications:

2012/1649 Lime Kiln Farm, Faulkland, Somerset BA3 5XE. Conversion of and extension of outbuilding to form holiday let.

2012/1916 Limekiln Farm, Faukland. Variation of condition 3 on planning permission 100016/010 to allow for use of the development as holiday accommodation and as ancillary residential accommodation to Limekiln Farm, Faukland

Cllr Drewe relinquished the chair to Cllr Brombley.

2012/2040 Hayside Barn, Upper Row Farm, Laverton, Bath, Somerset, BA2 7RB. Application for variation of condition 5 (occupancy condition) on planning permission 110479/003 to allow more flexible occupation of the holiday unit throughout the year to meet the needs of the occupant.

Cllr Drewe resumed the chair.

(iii) Distribution of the letter explaining the Mendip Strategic Housing Land Availability Assessment was due for completion within the following few days.

1770 Allotments

Bristol Water(BW) had introduced new requirements since supplying their quotation for connection of a water supply.

- BW will fit a double check valve
- PC will insulate the underground pipe and fit a stop tap to it adjacent to the water trough.

RESOLVED that Mr R.Watts be asked to carry out the PC work.

1771 Highways and rights of way

(i) Councillors disapproved of stones as a 'village gateway' to Faulkland and considered there was little room between road and hedge for a white-painted fence.

Highways to be asked again to repair the broken Faulkland village sign.

- (ii) A new solar panel had been fitted by Mr T. Gibbs and Cllr Drewe to the speed sign at the top of the village. Mr Gibbs was thanked for this and for making a new bracket.

Francis Brothers will cut the hedge adjacent to the speed sign.
